- 10. In our provisional order of fee determination for the year 2024 25 we have allowed 3% increase in fees over the fees determine for the year 2023 - 24. As per judgment of Honble' High court in special civil application no. 2352/2021 every self-finance schools may charge two months fees in addition to fees determine by the FRC. That menace school is entitled to collect two months fees upon fees provisionally determine by the FRC. If any school charges two term fee extra it amounts to 16% increase in fees if we do not allow any further percentage then also school is entitle to charge 3% increase as awarded in our provisional order plus 16% which amount to 19% increase in fees.
- 11. During hearing it is submitted by the authorised person of the school that if FRC allows 5% increase every year school will not charge any additional term fees. We think it fit to allow 5% increase instead of 19% increase in fees we have already increase 3% in our provisional order and in all we are allowing 5% increase it is in the interest of students.
